YOU MEAN I WASN'T STRUCK PERFECT

Step 7 was pivotal for me in my journey to recovery because it focused on the concept of humility. The step begins with the word "humbly" because in this step I am not merely about asking for help for myself but am embarking on deep, a trans-formative that process requires self-awareness, new acceptance of myself (the good and bad) and includes a humble request for change in order that I may be of more use to others.

Humility, at its core, means that I recognize and accept my limitations and imperfections. In my recovery, acknowledging my shortcomings is a daunting task because of my selfish and prideful thinking. Step 7 encouraged me to see past the false pride and confront my flaws openly and without pretense, and that is a big change from the defensive and prideful stance that I maintained while drinking.

As in Step 1, the main feature of Step 7 for me was the act of relinquishing control. My drinking career relied on the illusion of control I got from alcohol, making me believe I could manage my

life despite mountains of evidence to the contrary. When I asked my Higher Power to remove my shortcomings, I had to admit that I cannot overcome my defects on my own. For me this admission was a further act of surrender, a conscious decision to let go of my self-will and entrust my recovery to a Power greater than myself.

Humility also means a shift in my perspective. It means looking beyond myself and acknowledging the broader perspective of just "being human." This step helped me to see my personal struggles as part of the human condition, fostering empathy new connection with other alcoholics and other humans. Recognizing that everyone (even "normies") has shortcomings helped combat the isolation I felt in my alcoholism, and helped me feel a sense of my shared humanity and my participation in the human collective race's effort to overcome our personal flaws.

This step was also a much-needed lesson for me in vulnerability. It required from me a sincere and honest appeal for help, but this time my appeal was not based in

selfishness, arrogance, or entitlement. My request to my Higher Power to remove my short-comings was not about demanding an instant change, "striking me perfect," but instead expressing my genuine willingness to grow and transform. It was meant to convey an openness to receive the guidance and support from my Higher Power and from my fellow alcoholics, which are crucial for my sustained recovery.

The humility in Step 7 is also about a journey of continuous self-improvement. It is not a one-time plea but an ongoing commitment to my personal spiritual growth. Recovery is a lifetime journey, and embracing humility means consistently striving to become a better myself. involves regular version of It self-reflection, acknowledging new shortcomings as they arise, and maintaining a humble attitude towards self-betterment (see Step 10).

For me, my Step 7 sums up the important role humility plays in my daily reprieve from It is about acknowledging alcohol. my imperfections, relinquishing the illusion control, and seeking transformation through my Higher Power. This step fosters in me a of true connection, empathy, sense continuous growth. By embracing humility in Step 7, I can find strength in my vulnerability and make progress towards a healthier, more fulfilling, and more useful life.

Statement of Purpose

The purpose of the Central Office is to provide the basic services listed, to include, but not limited to:

- 2. To maintain a 24-hour Twelve-Step phone service, and to answer phone inquiries as needed.
- 3. To provide an A.A. listing in appropriate public sources.
- 4. To function as a clearing house for the circulation and exchange of information among all of the A.A. Groups in the area.
- 5. To compile, update and print meeting lists and other information about local A.A. services.
- 6. To maintain A.A. Conference approved literature and Grapevine literature for sale to members and the public.
- 7. To print and distribute a newsletter.
- 8. To be available to those in the community seeking information about alcoholism and A.A.
- 9. To maintain contact, refer inquiries and cooperate with General Service Committees and local groups.
- 10. To arrange, delegate, or manage the details of all Central Office events or any other functions approved by the CO Committee.
- 11. Specifically excluded shall be the operation of any club, clubhouse or drying-out place, and acts in violation of the Twelve Traditions and promotion thereof.
- 12. Provide a limited number of Anniversary coins.
- 13. Such other activities that are consistent with the principles of the Twelve Traditions.

OUR TRIP TO AKRON

AA Behind the Walls

Bill W. at the St. Louis Convention told with obvious glee how what he called "AA's first prison group" came about in 1942. Even prior to that time, Bill said, San Quentin's enlightened and liberal warden, Clinton T. Duffy, had given much thought to the urgent and pressing problem of prison reform, including the special needs of the inmates imprisoned for crimes committed while drinking. As Warden Duffy said, the program he proposed included education, vocational training, medicine, psychiatry and religion. All of this would not help the alcoholic if the problems which drove him to drink were not solved. In line with this new approach to rehabilitation, I looked upon Alcoholics Anonymous as a tool to help us rebuild lives.

To Warden Duffy's aid came Warren T. and other members in 'the San Francisco area. Bill continued, as Warden Duffy has since said, had it not been for the regular help and understanding given by our AA friends outside, the San Quentin chapter of Alcoholics Anonymous would most assuredly have failed. And by the same token, if it had not been for the persistence of that first group of alcoholic inmates who realized their serious problem and their need for help, we never could have continued beyond the first few meetings.

But even with such enthusiasm and willingness, there were formidable problems to solve. Bill pointed out to the St. Louis audience, AA meetings would bring carloads of AA's from the outside running in and out of prison. They would probably draw the ridicule of other prisoners. Those penologists who still thought hard-boiled methods to be the only way and those skeptics who thought AA only a 'useless fad' would shake their heads. It would mean large gatherings of prisoners unattended by guards. The risks were great, but Warden Duffy took them, and his faith was justified.

AA soon won the respect of other prisoners. AA's came and went freely. The meetings had only one guard stationed outside the meeting room. The clincher came, according to Bill, when the recidivism rate of alcoholic prisoners suddenly dropped from the usual 80 percent to a spectacular 20 percent, and held that way. Skeptics everywhere were convinced. This piece of pioneering made AA history.

Bill spoke these words at San Quentin's AA group meeting on November 28, 1943.

Remarkable Trip to Akron

My Sponsor and I had this great idea, (I know what you're thinking). We planned this to Akron with a group of AAs but it only my sponsor and I who flew from Salt Lake City to Cleveland in 1999. I wanted to experience first hand; you know, the what, how, where and when of AA. As a newbie in AA, I was curious what made people want to help others and to give so much of themselves without expecting anything in return.

We landed in Cleveland, rented a car and drove 40 miles to Akron. The following morning we toured the Seiberling Mansion. We peered through the Gatehouse window, the location of Dr. Bob and Bill's first meeting. It was inspiring to think of how this lifelong friendship began. Bob said he was willing to listen to Bill for 15 minutes but ended up talking to Bill for 5 hours. I wondered what was discussed during that first meeting. After all, this was the beginning of AA.

Afterwards, we drove to Mount Peace Cemetery. It was such a spiritual experience to feel the gratitude of so many visitors as evidenced by hundreds of Birthday tokens tossed on Dr. Bob's graveside. We headed to Akron Central Office and took their guided history tour. We found it hard to leave because of the plethora of history found there. It was fascinating!

The next day we visited the Mayflower hotel where Bill Wilson made that historic telephone call to Reverend Tunks and Henrietta Seiberling. Henrietta arranged the first meeting between Bill Wilson and Dr. Bob. That evening we attended the first AA meeting in Akron, at the King School. We learned the original AA meeting started in Dr. Bob's home and later relocated after exceeding capacity.

We made a visit to Dr. Bob's historical home and took the unforgettable guided tour. We climbed the 12 steps leading up to their front door. It was thrilling to hear so many stories of Dr. Bob and his wife Anne.

During our last day, everything I experienced began to sink in. I developed a deeper appreciation for all the hard work that went into this program to save an old drunk like me. I have a deeper understanding of "in order to keep it, you have to give it away."

That remarkable trip to Akron was a great way of getting to know my sponsor. As a result, we developed a deep friendship. I cannot remember a more enjoyable way of discovering AA history. What a gift to be able to enjoy and appreciate the many treasures found in sobriety.

Central Office Meeting Minutes - June 2024 "Serving our community for over 75 years"

BOARD OF TRUSTEES

Chair: Wade J. – No introductions due to time constraints.

CO-Chair: Shannon M. – Excused

Secretary: Jennie S. – New reps - Please send email/phone number to secretary@saltlakeaa.org Fred from Fresh Air made a motion to approve May meeting minutes. Jim S. seconded - PASSED

New Business:

- 1. At the board meeting we talked about posting our Financials on our website. Fred (Fresh Air) brought up that we are a 509C3 so our financials are public information anyways, so anyone can access them. Wade made a motion to approve putting "Financials Available Upon Request" on our website, along with the treasurer email address PASSED
- 2. Declan noted that the Events on our website continue to be outdated at our board meeting. We discussed creating a new position under the webchair to exclusively manage events. Discussion ensued Declan stated that the current way is not working but supports someone to gather events. Fred brought up that we don't need permission to clear old events so we should go ahead and do that. We also discussed which activities we put on our website and it was decided only those under Salt Lake Central Office's jurisdiction. Wade asked Jeff to think about having someone working under him and report next month.

Treasurer: Chris G. -

- We had to pay our accountant for tax prep/filing for the past three years, which increased our accounting expense. We also paid for insurance this month, which was about \$670. Without those two expenses, we were essentially at break-even for the month.
- The primary reason we ran a loss was that we saw a decrease in donations around 25% year-over-year in May, as well as a decrease from the donations we'd received in previous months.
- Also, I have received some receipts from Amanda to begin updating COGS. More to come on that front as I work through it.

Donation check bounced from the Park City group so he needs to talk to the rep after the meeting Mike wanted some clarification on paying the accountant - last year it stated we paid her for the last 2 years while this year, it was 3 years. Chris clarified that it was a cumulative of 3 years. Charlie wanted numbers on the purple can. Chris will look at it and let him know. Wade made a motion to approve May Financials - PASSED

Trustee at Large: John S. (District 2 Liaison) – Reference District 2 Newsletter and David R's report.

Trustee at Large: Declan (District 10 Liaison) -

David R. the Area Delegate gave a presentation at District 10 on June 3rd, report attached. There were 25 in attendance, 15 of whom were GSR's. Standard reports were bypassed or limited in favor of extending the time available to our visitor.

Trustee at Large: Phillip W. (District 11 liaison)

- Dist 11 meeting was heavy towards final plans for hosting the May 18 Area Post Conference Assembly. It was a success.
- The district voted to put suggested meeting contributions on agenda. These percentages are per the AA brochure titled Self Support.

Trustee at Large: Alan B. (District 13 Liaison) -

- The May GSR meeting was well attended but slightly down from April. There were 19 in attendance. Tony, the DCMC chaired the meeting. He gave a great report on the Post Conference Assembly and various motions that were approved or otherwise. Several other GSRs and Standing Chairs also gave favorable reports regarding the assembly. The only negative report was regarding audio equipment and difficulty of running the hybrid meeting. There were other comments from GSRs that the Zoom meeting was particularly challenging and the poor audio made it hard to focus and listen.
- In regard to that, there was a discussion regarding a Proposal / Motion made: Spending \$1500 for new audio equipment. This will be brought back to your groups. Some of the funds may be reappropriated from other budgets with a possible surplus.
- There are some new insurance changes and any area hosted events will now be covered by Area 69. The cost of this liability coverage is \$420 per year. This is required to reserve most venues.
- Like many districts, areas, and here at Central Office, District 13 is starting to look for folks wanting to serve and step into positions this fall. There are some positions open now but all will be open soon. There are 2 chairs currently open. They are Public Information and Communications. Come join us at District 13 or here at Central Office and expand your AA horizons.
- The newest DCM reported attending 3 meetings and gave updates about those groups. It is great to have her on board as she can support the many women's meetings in District 13.
- In general all the GSRs reported strong attendance with newcomers, old timers, and everyone in between.
- The meeting closed with a discussion on financing regarding meetings, groups, etc. Getting EIN numbers and other financial tools for groups can be tricky. Do it correctly and get advice if needed.
- Come check out the next District 13 GSR meeting. As always, the District 13 Newsletter "New Brew" is attached to your email. It is full of great information. Reach out to me for anything you need. Bylaws: Brad C. – 2 proposals to be submitted for Amendment:

- 1. Eligibility for trustee. At present, our bylaws state "minimum of 2 years sobriety and 1 yr Central Office committee membership." Looking to strike the latter. Also affects Board of Trustees replacements. We need a majority ½ vote required to make by-laws change. Take back to your groups to get feedback.
- 2. Current requirements for the Central Office chair position is 2 yrs of sobriety with a subsequent 2 year requirement to stay on as an immediate past chair (for a total of 4 years). Looking to change the latter to 6 months. Open Discussion: Fred from Fresh Air brought up the concept of "institutional memory" i.e. the use of collective memory to interpret laws and assign authority-worried that a 6 mo vs 2 yr tenure wouldn't be enough time to pass along the necessary skills/info to the next Chair. Nick R. suggested 1 year instead of 6 mo. According to Robert's Rules, we vote to strike down the amendment before proposing a new one, so that discussion isn't currently relevant.
