BLESSINGS THEN AND NOW

A Prisoner reflects on AA inside

AS I SIT HERE in this cell at the Utah State prison, my mind has been revolving from the past to the present, trying to compare the blessings I've received in life — in the "past" and in the "now." Somehow, when I started this, I was sure the past would outweigh the now. But I was fooled. Even though I could list many more events of the past which I thought were blessings, I found they were just that, "events." I did not take those events and use them as blessings. And all those events remain only memories and have long gone out of my life. Yet in the "now" I can see and list blessings which are still with me and as long as I keep active in the principles of the Twelve Steps, those blessings stay with me.

Today I have life and enjoy it, if one can believe life exists locked up behind bars. Before I got here I was dying the slow death of a practicing alcoholic. Even in here, I could have continued on that path just as easily as on the outside. But I had the fortune (blessing) of knowing that Alcoholics Anonymous existed. And I made the decision that this was truly rock bottom for me and that I had to surrender completely. Another blessing on the "now" side.

After arriving here, I was corresponding with an aunt of

mine in Texas. She told me my sister wanted to write and help me while I was here in prison. So, big deal? It is when my sister and I haven't corresponded for over twenty years. The first few letters were full of pain, but that is gone out of our letters and the joy of brother and sister love flows in each weekly letter. What a blessing!

When I got on this block I investigated for an AA meeting. There was a mandatory meeting where you received points for attending and the hope of getting an extra family meeting in the future. Needless to say the inmates came in body for those reasons. They wanted the points so they could look good before the board of pardons. The only participation was, "Did you mark me down for my points?" and "When are we getting the family meeting?" Then complete silence. Another blessing, even though it doesn't look or sound like one. But it did at least get the bodies there. (Since our progress has been on the up, the point system is no longer in effect.)

I wrote to New York, asking for information on the "Gold Key" group, as to whether it was registered, etc. They sent me all sorts of information dating back to 1946.

Through my correspondence with GSO I got all sorts of literature, including some Big Books and the "Twelve and Twelve." They sent my letter on to the Grapevine, as I had inquired about a subscription to the Grapevine given to me by my home group. The Grapevine sent some AA material also. More blessings.

We now have two meetings a week, one Step study and a Spanish-speaking meeting. We are waiting for Spanish literature, Big Books, the "Twelve and Twelve," and Living Sober, which are on the way from New York. More blessings!

I go before the board in two days to receive my release date. It could be a release date from zero to five years for forgery of a \$100 check. Most people who are supposedly in the know say a six-month date, meaning I could apply for a halfway house and be out of here before Christmas. More blessings!

The biggest blessing is the fact that I've truly found my Higher Power. No way could I have considered any length of time behind bars as a blessing. But it truly has been. I certainly don't recommend coming to prison as a means of achieving blessings, but for myself, I wouldn't change it. Because of the time I have spent on meditation and prayer, the prayers answered, the growth I have experienced, the love, and the ability to truly look at myself have all been blessings. And I'm able to experience all these blessings each day of my new life. And I truly believe my Higher Power will be with me when I get out, no matter when the board decides that will be.

Another thing, our AA meetings have grown in body, as well as in participation. We are getting an "all groups" meeting for January--a three-hour meeting with outside guest speakers, with AA members from unit I, unit II, and SSD unit grouped together and some time afterward for fellowship. That is quite an achievement, but most

of all it is another blessing. Not only has God answered my prayers, but he sent the bodies of other willing inmates to help.

So now, even though I'm locked up, the events of each day are no longer just events.



BLAST FROM THE PAST

May 22 and 23rd, 1951 Bill W. comes to Utah

The Utah Committe on Alcoholism held its annual meeting on May 22nd, 6:30 p.m. in the auditorium of the South High School, 1575 Main St., Salt Lake City. The meeting was scheduled for this time and place to enable members of the Committe who live outside of the city to attend both this meeting and the public meeting at which Bill W. co-founder of AA spoke.

The Utah Assembly of Alcoholics Anonymous in cooperation with the Utah State Board on Alcoholism and the Utah Committee on Alcoholism sponsored a public meeting Many 22nd in which Bill W. was the featured guest. The meeting commenced at 8:00 p.m. in the auditorium of the South High School.

There were three AA closed meetings held on May 23rd, attended by members of the fellowship from Colorado, Idaho, Montana, Nevada, Oregon, Wyoming, in addition to the hundreds from Utah. There had been some talk of making such a meeting an annual affair.

On the evening, May 23rd, a closed meeting for members of Alcoholics Anonymous and their husband and wives was held in the Lafayette Ballrooom at the Hotel Utah, Salt Lake City. This meeting started at 8:00 p.m. Bill W. was the featured guest.

Bill W. attended the Monday Night Meeting at Altrum Hall while he was there for the Skyline Conference. While there he 12-Stepped a fellow who showed up drunk, his name was Lou F. He stayed sober.

The meetings at which Bill W. co-founder of AA spoke were a huge success. An estimated total of over four thousand people heard him speak at five gatherings at which he was the featured speaker. Nothing but praise was heard for Bill and the message he left.

Bill W. co-founder of AA along with 704 guests present signed the register.

77th Anniversary of Salt Lake AA Central Office

In 1947 our first AA Central Office of Salt Lake City opened at 216 Ness Building SLC, UT.

In 1986 AA Central Office moved to 2520 State St. Room #154 Valley Professional Building, SLC, UT.

In 1987 AA Central Office moved to 2480 S Main St. #112 in SLC, UT. This location was a small office space of 225 square feet.

After the turn of the century, there was a great need for more office space to accommodate AA expansion in the Salt Lake Area.

In October 2006, AA Central Office moved to 80 W Louise Ave, SLC, UT. This new office space came with 2,000 square feet to carry out numerous AA activities.

In January 2012 an unprecedented change took place. AA Central Office of Salt Lake City was struggling with finances and a suggestion was made to downsize the Central Office to accommodate the current budget or try something new, something that hadn't been accomplished before. The Board of Directors voted to transition from paid full-time office managers (Ron K. and Sandy A.) to an all-volunteer staff.

In January 2012, the great experiment called, "This Will Never Work!" began. After all, most all AA Central/ Intergroup offices employ at least one paid full-time secretary or manager, as well as AA volunteers - members who respond to Twelve Steps calls, answer the telephone, and carry out many other office duties. Twelve years later AA Central Office is entirely volunteer run, with the goal of helping anyone who has a desire to stop drinking.

At AA Central Office we created an attractive room for literature and a Global Presentation of AA all over the world, displaying 64 languages with a map that lights up to show where the languages are spoken. We have a comfortable front office where we pass information on to members and newcomers. We have a larger room used by AA trustees and chairs to conduct business meetings. We have a literature storage room and a break room. In 2018, the building owners agreed to expanding the north side of the building to accommodate a new archive room. The archive room officially opened in March of 2019.

In 2024 we list over 470 AA meetings on our Salt Lake Central Office website. Over 300 after-hour Hotline calls are received monthly. More than 2,000 Lifeline Newsletters are sent out each month. About 5,000 guests visit the AA Central Office website monthly. Vistors are always welcome. Please stop by for a free complementary tour of the Salt Lake AA Central Office.

Central Office Meeting Minutes - April 09, 2024 "Serving our community for over 75 years"

BOARD OF TRUSTEES

Chair: Wade J. – Opened the meeting with introductions. Shannon read Central Office By-Laws.

CO-Chair: Shannon M. –nothing to report

Secretary: Jennie S. – New reps - please get me your email, phone number and homegroup before you leave. Also, we are going to start voting to approve the previous month's minutes at each meeting, so please review them before coming. Highlights from March:

- Treasurer's Report stable financial footing
- Declan voted in as Trustee at Large for District 10
- Patty N. voted in as Alternate Trustee at Large for District 2
- Public Information Chair and Alternate Trustee at Large Positions remain open
- See transcript of full minutes for Committee Chair reports

Phillip W. made motion to approve the March minutes, John S. seconded.

Treasurer: Chris G. – excused. Wade went through P&L line by line (see attached) Jim made motion to approve the March P&L statement, Nick seconded.

Trustee at Large: John S. (District 2 Liaison) – Went to the meeting yesterday 4/8 and the takeaway was an emphasis of the AA power structure: at the top is the Members, next Groups, Districts, Area, then AA World Services. The role of each Central Office is serving the Districts (see attached PDF). Please encourage your groups to stay updated and consider the issues that General Service is voting on. On a side note, District 2 has started publishing a newsletter.

Trustee at Large: Declan (District 10 Liaison) - I attended the District Ten meeting on April 1. With 26 present, attendance was a bit light. Some GSRs didn't show up due to confusion over the Easter holiday. Rick with Bridging the Gap reports that some districts that have no BTG. He doesn't know how much of that reflects lack of interest, and how many of interest, but no program to assist. So he's considering the need for an Area BTG. But he's planning on get-together to gather more information. Thomas with Treatment is holding panels for District treatment centers, where four or five AAs come in to speak about their ESH, to help clients understand how they could benefit from AA. These are open to AAs from all districts, and I've provided flyers that can be taken to meetings. I attended the Area Pre-Conference Assembly and saw Babs in active service, the Alternate DCMC active in service, and had the pleasure of meeting with our US Trustee at large.

Trustee at Large: Phillip W. (District 11 liaison) Meeting held March 13th with 22 attendees.

- 2. District voted to add seed money for the upcoming area conference. Expects to be made whole.

SALT LAKE CENTRAL OFFICE Statement of Purpose

The purpose of the Central Office is to provide the basic services listed, to include, but not limited to:

- 1. To carry the A.A. message and help those individuals who suffer from alcoholism.
- 2. To maintain a 24-hour Twelve-Step phone service, and to answer phone inquiries as needed.
- 3. To provide an A.A. listing in appropriate public sources.
- 4. To function as a clearing house for the circulation and exchange of information among all of the A.A. Groups in the area.
- 5. To compile, update and print meeting lists and other information about local A.A. services.
- 6. To maintain A.A. Conference approved literature and Grapevine literature for sale to members and the public.
- 7. To print and distribute a newsletter.
- 8. To be available to those in the community seeking information about alcoholism and A.A.
- 9. To maintain contact, refer inquiries and cooperate with General Service Committees and local groups.
- 10. To arrange, delegate, or manage the details of all Central Office events or any other functions approved by the CO Committee.
- 11. Specifically excluded shall be the operation of any club, clubhouse or drying-out place, and acts in violation of the Twelve Traditions and promotion thereof.
- 12. Provide a limited number of Anniversary coins.
- 13. Such other activities that are consistent with the principles of the Twelve Traditions.

Alcoholics **Anonymous®** fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism. The only requirement for membership is a desire to stop drinking. There are no dues or fees for A.A. membership; we are self-supporting through our own contributions. A.A. is not allied with any sect, denomination, politics, organization or institution; does not wish to engage in any controversy; neither endorses nor opposes any causes. Our primary purpose is to stay sober and help other alcoholics to achieve sobriety.

What A.A. Does Not Do

- 1. Recruit members.
- 2. Keep membership records records or case histories.

- 3. Do Research.
- 4. Affiliate with social agencies, though many members do cooperate with such agencies.
- 5. Follow up or try to control its members.
- 6. Make medical or psyshological diagnoses or prognoses.
- 7. Provide hospitalization, drugs, or medical or psychiatric treatment.
- 8. Engage in any controversy about alcohol or other matters.
- 9. Provide housing, food, clothing, jobs, money, or other such services.
- 10. Offer religious services.
- 11. Provide domestic or vocational counseling.
- 12. Accept any money for its services or any contributions from non-A.A. sources.
- 13. Provide letters of reference to parole boards, lawyers, court officials.
- 14. Furnish initial motivation for alcoholics to recover.

UTAH STATE PRISON HOUR OF HOPE

DAY ONE

I WAS NEVER exactly sure of my sobriety date. I didn't really know I was supposed to have one. Every now and then someone in AA would mention their sobriety date, and I'd think, "Boy, they had the wherewithal to write it down on a calendar." After a while in AA, someone approached me and asked if I was coming up on my birthday. I now had a need for a sobriety date. I needed it to determine my birthday. It was suggested that since almost all alcoholics leave a paper trail, that I should review my records looking for an anomaly that would indicate when I got sober. It didn't take long to find it.

I was stationed at Nellis Air Force Base in Las Vegas, Nevada. In early May, 1978, I wanted to go out on the town. There was one small problem; my car was in a garage. It was being repaired due to the damage done when I had driven it over a cliff in a suicide attempt. In order go to town I had to borrow a car from my friend "Wild" Bill.

I stayed out quite late. On the way home I had to go through the main security gate to return his car to the base. The gate guards pulled me over because his car had a broken headlight. I rolled down my window to await their next instructions. They asked for my license and registration. I don't know what gave me away; it might have been the smell of booze when I rolled down the window; it might have been the stack of empty beer cans in the back seat; or, it might have been the awkward display I made while searching the car for Bill's registration.

I got out of the car and took the field sobriety tests. I thought I nailed it. They weren't convinced. The main gate at Nellis AFB is within walking distance to the base hospital. They walked me into the hospital lab for a blood draw. My Blood Alcohol Test (BAT) came back a .21; not what I had hoped.

I was immediately arrested and my commanding officer was notified.

I was ordered to appear before my commanding officer May 22, 1978. I know this because of my "paper trail." I was given an Article 15. An article 15 allows my commander to dispense punishments without a court martial. It can include a fine, a demotion, a discharge or any combination of the three. I know for 100% certainty that on May 22, 1987, I was sober as I stood before my commander, and I haven't had a drink since. Thanks to my paper trail, I now had a sobriety date.

My commander had a flare for the dramatics. He had everything in his office removed except his chair, his desk and a chair for me. On his desk were two piles of papers. In the first pile was the Article 15, a fine and a discharge. In the other pile was the Article 15, a fine, suspended demotion and enrollment into an alcohol treatment center.

Here was my dilemma. The first pile of papers meant no treatment center, but I lost my job. Somehow I believed that alcoholics were unemployed and by losing my job that would be an indicator that I was an alcoholic.

The second pile meant I could keep my job, but I had to go to treatment, also an indicator that I was an alcoholic. There were indications that I was an alcoholic regardless of which pile I chose.

So I chose the pile that made the best economic sense, pile number two, keeping my job, keeping my rank, a reduced fine and treatment. That was day one of my sobriety.
