### NO ROOM TO COMPLAIN

There was a man who lived in the late 1800s and drank excessively. He was a professional horseman, buying, selling and trading horses. The details are uncertain, but the cause of death was listed as "kicked in the head by a horse." Needless to say, he never drank again.

Another man, who lived in the early 1900s, also drank excessively. He acquired diabetic foot pain (neuropathy) as a result of his drinking. He could no longer walk to the tavern. He never drank again.

There was a World War II veteran who had a good job with a manufacturing company. He was a heavy drinker. He lost his arm as the result of an industrial accident. He never drank again.

Be careful when you shake the family tree, you don't know who's going to fall out. All three of these men can be found in my family tree. Maybe things would have turned out differently for these men if you could have gotten a DUI on a horse, or if treatment centers were available or if Alcoholics Anonymous had existed back in the day. We'll never know. What is known is that these men followed their disease to the ultimate conclusion.

The first AA meeting in my home state wasn't until 1944, and it was on the other side of the state.

It would be another sixteen years before AA's message would reach my home town. These three men, the horseman, the diabetic and the veteran, never got to hear the message of Alcoholics Anonymous.

Another thing that has changed over the years is the requirements for AA membership. In the beginning the bar was set high. In the story "AA Number Three," page 186, Bill and Bob ask Bill D. four questions. The first question was, "Do you want to quit drinking?"

If Bill D. had said "No" then Bill and Bob would have moved on, looking for someone who wanted to quit. The second question was, "Can you quit of your own accord?" If Bill D. had said "Yes" then Bill and Bob would have moved on, looking for someone who needed their help. Because Bill and Bob both felt that the solution was a spiritual solution, their third question was, "Do you believe in a Higher Power?"

If Bill D. had said "No" then Bill and Bob would have moved on, looking for someone else to present the spiritual solution they had found. The fourth question was, "Are you willing to go to this Higher Power and ask for help?"

If Bill D. had said "No" then Bill and Bob would have moved on, looking for someone who could accept a spiritual solution. Back then, there were no court referrals, no treatment center tourists, and no marriage saving members in the group. Today, thankfully, the only requirement for membership is a desire to stop drinking.

I didn't die. I didn't drink myself into a disability. I didn't lose a body part. I was lucky enough to have been born in a time when Alcoholics Anonymous existed. I was also fortunate enough that Alcoholics Anonymous had lowered the bar so even I could join. The outlook for an alcoholic has changed dramatically; in 1935, everyone knew someone that was an alcoholic and by 2018, everyone knows someone in recovery.

All the stars lined up for me to be saved from a seemingly hopeless state of mind and body and eventually a horrible alcoholic death. I have no room to complain.

- 2. To maintain a 24-hour Twelve-Step phone service, and to answer phone inquiries as needed.
- 3. To provide an A.A. listing in appropriate public sources.
- 4. To function as a clearing house for the circulation and exchange of information among all of the A.A. Groups in the area.
- 5. To compile, update and print meeting lists and other information about local A.A. services.
- 6. To maintain A.A. Conference approved literature and Grapevine literature for sale to members and the public.
- 7. To print and distribute a newsletter.
- 8. To be available to those in the community seeking information about alcoholism and A.A.
- 9. To maintain contact, refer inquiries and cooperate with General Service Committees and local groups.
- 10. To arrange, delegate, or manage the details of all Central Office events or any other functions approved by the CO Committee.
- 11. Specifically excluded shall be the operation of any club, clubhouse or drying-out place, and acts in violation of the Twelve Traditions and promotion thereof.
- 12. Provide a limited number of Anniversary coins.
- 13. Such other activities that are consistent with the principles of the Twelve Traditions.

I'd drank up my family and friends dear to me I'd imprisoned myself and could not find the key I gave up on life and I wanted to die I felt that I was insane but I didn't know why. But, by the grace of God the day finally came When I came to in Detox and could not bear the pain

Something now told me that if I was to live I must seek help, be honest and be willing to give.

That one day in my life, just four years ago
I had felt so desperate, that I had to let go.
I entered in treatment and once again found AA
I would just crack the door and quite often I'd stray.

After four years of struggling not knowing what for I've been humbled, got honest, and God opened that door.

To admit I was beat was a hard thing to do But without God and AA, I know my life would be through.

I've become willing to accept life for what it is now For it's God love and AA that have shown me how.

As I sit here in Jail, once again my old home It's the first time in Jail that I don't feel alone. I pray every night and thank God up above For ever before have I had strength and love.

For the first time locked up I now feel I am free For thank you dear God, I now have the key, The key to life and happiness.

# Central Office Meeting Minutes - October 2024 "Serving Our Community for Over 75 years"

#### **BOARD OF TRUSTEES**

**Chair: Wade J.** – Opened with introductions.

**CO-Chair: OPEN** 

**Secretary: Jennie S.** – Advised new Reps to send email/phone number to secretary@saltlakeaa.org or come see her after the meeting. ⇒ Motion to approve the September minutes made by Declan, Elan seconded.

**Treasurer: Chris G.** – Takeaways: September was slow from an income standpoint. We lost about \$300 on lower contributions and slightly higher expenses. Group contributions were down 25% year-over-year, leaving us at year-to-date growth of 6% in contributions (still outpacing inflation).

In the Profit-Loss statement, we should have \$67 in purple can contributions - I'm guessing the donation from the Acceptance group was classified as an "Other Contribution." 

Motion to accept financial report as written made by Elan, Bob seconded.

### Trustee at Large: John S. (District 2 Liaison) -

District meeting is on the second Monday of the month so no report.

### Trustee at Large: Declan (District 10 Liaison) -

Some years back, as our printed meeting schedule grew, we turned it over to a software engineer to build, as the process had become too burdensome for volunteers to do by hand. So he or she would build a snapshot that would be distributed to volunteers for printing. This snapshot would become outdated over time, while Central Office would continue to print meeting schedules dated by two or three months.

But with time, we've created a program that makes it as simple to print an up-to-date schedule as loading a web page and pressing the print button. That allows a volunteer to print a meeting schedule that is always up to date, with no need for a software engineer. And if that tool were put in the hands of volunteers, the schedules printed today would have had the meeting changes that our webservant approved within the last twenty-four hours.

Instead, it could instead take about a month, possibly two or three months, for those changes to show as we continue to rely on an outdated intermediate build process. The new program is free, open source, easy to use, and the process costs nothing more than what we currently do. So I would like to invite anyone who is considering standing for volunteer chair to take a look at this tool, so that volunteers can regain full control over the meeting schedule process and be able to print up-to-date schedules at any time to better serve our fellowship and the districts we serve.

Last night, at our District 10 meeting, I had an opportunity to meet with Donnie G, our area Public Information Standing Chair elect from District 1, who accompanied our area delegate and delegate-elect, for

District 10 elections. He presented meeting schedule cards that can be distributed to anyone, and last night, he was kind enough to give me three-hundred of them. In turn, I passed out some samples earlier, and am giving the remainder to Central Office. I thought that maybe we could place them on our front desk for anyone to take, or even put one in with each of our meetings in a pocket.

District Ten elections went well. We had an attendance of thirty one, and elected a DCMC, Alternate DCMC, two DCMs, a Treasurer, BTG chair, Treatment chair, Grapevine chair, and Literature chair. We were told someone is standing for Corrections, as well, but were unable to be present last night. District still has open the positions for two DCMs, Secretary, and CPC chair. Thank you for the opportunity to serve!

**Trustee at Large: Phillip W. (District 11 Liaison)** District 11 filled all their officer positions, still have some open committee chair positions, and will send a complete update.

#### Trustee at Large: Alan B. (District 13 Liaison) -

District 13 had a great meeting last month. Elections are held on even years in District 13 in September. David, Area 69 Delegate, Teresa, Alternate Delegate, and Mike, Area Chair were there to assist and conduct the elections. They read each position's requirements and job descriptions.

Tony, the current Alternate DCMC, stood for DCMC and was voted in unanimously. He will replace Andy who did a fantastic job for the last two years. Thanks for your service Andy!

About half the positions were filled on election night and the other half of the positions are still open.

John S. wondered if we could give a monthly shout out to the volunteers at Central Office; it was decided that most people wouldn't want the recognition.

Bob brought up the possibility of staggering Committee Chair term positions so they didn't come up all at once every 2 years. Discussion tabled for later.

"Simplicity, devotion, steadfastness, and loyalty; these were the hallmarks of Dr. Bob's character which he has well implanted in so many of us"

Bob held three concepts in particularly high regard. One was simplicity — in his own lifestyle and in practicing the A.A. way of life. Second, he believed in tolerance of other people's ideas, in speaking out "with kindness and consideration for others," and in "guarding that erring member, the tongue." Third, he believed that one's job in A.A. was to "get sober and stay sober" and "never to be so complacent that we're not willing to extend that help to our less fortunate brothers."

Dr. Bob firmly believed that "love and service" are the cornerstones of Alcoholics Anonymous.

### Bill W.

"It was five years ago I first met you, Bill. I shall never forget, nor cease to be grateful."

Bill's service to A.A. spanned 36 years, during which, with the help of other old-timers, he formulated A.A.'s recovery program, codified into a set of Traditions the first 10 years of its group experience, wrote four books for the movement, and contributed numerous articles about A.A. to internal and outside publications.

Bill often spoke before medical, psychiatric, and religious societies, and testified (in closed session) before various state and Federal legislative committee hearings on alcoholism.

During his lifetime, he declined all public honors, setting an example for the whole Fellowship.

#### **GREAT NEWS IN 2024**

In March 2024 an idea of a "Podcast for the Deaf" was thought of in San Francisco at PRAASA.

On July 1, 2024, the Grapevine moved the project forward calling it a "Vodcast" because it is visual rather than audio.

August Grapevine announced having three Vodcast available to view on AA Grapevine Vodcast.

In order to tell a Deaf member's message, they cannot sign it because their face will break Anonymity. To tell the story we need to hire an Interpreter to sign their message. Each Vodcast Interpreter will cost between \$130.00 and \$190.00.

The 5:30 Sobriety Hour has given permission to send the groups Purple Can donations to the new Vodcast.

Since July 2024, the 5:30 Sobriety Hour has contributed \$1,109.29.
