A GOD OF MY UNDERSTANDING

In high school I was socially awkward and thin as a rake. I didn't fit in with my peers. One school weekend I had my first drink of alcohol. I felt this calmness and peace come over me, I thought it must be the elixir of the Gods. That first drink magically removed my fears and insecurities. It made me good looking, hip, slick, and cool. Because of this effect produced, I drank whenever I could.

After Hight School I married my childhood sweetheart. I worked hard during the week and drank excessively on weekends. One day my wife told me I was drinking too much and that I need to slow down. This was disturbing, I thought I hid the excessive part so well. Soon, my weekends started to include adjacent weekdays.

My wife's wish to slow down was challenging because I struggled to control my drinking. Once I started drinking I couldn't stop, I kept drinking until I passed out. When I tried to control my drinking I didn't enjoy it, and when I enjoyed my drinking, I couldn't control it.

I promised my ever so patient wife over and over that I was "going on the wagon for keeps." I tried everything I could think of. I switched from beer to wine, counting my drinks, only drinking with meals, drinking only at our home, not drinking alone, and having a glass of water between drinks. I tried new hobbies, sports, and exercise. My grandiose plans always failed me.

My insanity continued for many years until I got sick and tired of chasing that "original high" from my first drink.

After my last drunk on New Years Eve 2013, I decided I was done for good.

I didn't know how I was going to find the strength to *stay* sober. Then I attended a family rehab meeting and the instructor said, "You don't ever have to drink again, even if you want to." They said Alcoholics Anonymous is a good place to start. I was ready to investigate, so I went the nearby AA meeting and heard members share stories similar to mine. I continued to go to meetings to learn how to live life without drinking. I was given a Big Book of Alcoholics Anonymous and while reading it, I felt like I was reading parts of my own story.

The "God thing" written in the 12 Steps really bothered me because of my past experience with organized religion.

After comprehending "A God of my own understanding," it became acceptable for me to turn my life over to the care of a higher power. Little by slowly, my higher power had changed from this punishing God to a merciful and loving God. My earlier conception of God was that he found drunks disgusting and not worth saving.

I believe God or my higher power inspired this AA organization, established in 1935. It's still going strong after 90 years. I love that AA is a simple program, with only one requirement for membership, "A desire to stop drinking."

And as for the "God part," I don't fully understand it, but it's comforting for me to know I only need is to be open-minded and willing. It takes affirmative action for me to turn my will and my life over to a higher power on a daily basis. Today my life is amazing, without drinking. I have found this calmness and peace that I had looked for all those years ago.

ONE ISSUE AT A TIME

Alcoholism is an incurable disease contracted by you might say, 10% of the population. It is an incurable disease, but it can be arrested. It is no respecter of age, gender, intelligence, religion, or economic status. Why, you might say, 90% of the population can drink with impunity is hard to understand but we who have been in the AA program for a while, know that you can adopt a way of life that removes the obsession to drink without the white knuckling side effects and you will be comfortable in your own skin without the use of medicine.

The symptoms of alcoholism are a combination of mental, physical, emotional, and spiritual in nature. The alcoholic awakes every morning to face, "The hideous four horsemen, Terror, Bewilderment, Frustration, Despair." (pg. 151 BB.) Doctors, Counselors, Priests, and Ministers, when afflicted, come to AA to get relief from this horrible disease. When our desperation out-weighs our denial we show up at the doors of Alcoholics Anonymous and discover a road map to a life of peace and happiness that we believed did not exist.

Alcoholism is a progressive disease and Alcoholics Anonymous is a progressive solution and not a quick fix. These desperate alcoholics find a degree of hope and comfort when first exposed to the AA group and the laughter and lighthearted banter going on between the members before the meeting even starts. They hear members sharing about Guilt, Shame, Fear and Insecurity and they identified with these symptoms. They hear laughter when a person describes a horrible incident in their life and they think they are laughing at the horror but, in fact, they discover that the laughter was focused on the absurdity of our alcoholic thinking, at the time, and they all identify with it.

They begin to understand that guilt, shame, fear, and insecurity were the core issues that could quickly be put to rest by alcohol and halfway through their second drink everything seemed right with the world. The world had not changed but their perception of it had.

To compensate for the fears and insecurities they had to protect their turf, so they learned how to rationalize those established behavioral patterns they were not proud of. Family responsibilities took a backseat to the boozing and their family let them know about it, so, back to the bar they went. The guilt and shame weighed heavy on their mind and to drink would take care of that temporarily.

In the program they come to learn how to admit their mistakes and make restitution for all those faulty behaviors and get on the positive side of the ledger. "---Selfishness---Self-Centeredness! That we think is the root of our troubles. Driven by a hundred forms of fear, self-delusion self-seeking and self-pity we step on the toes of our fellows and they retaliate". (BB pg.62) Can you blame them?

There are 12 steps in the program of Alcoholics Anonymous and each step is preparatory to the next. If we give due diligence to every one of those 12 Steps, we evolve into the person we always wished we could become.

We can't stop drinking if we can't stop the alcoholic thinking. Again, In the program, each day seems better than the day before. One day at a time. One issue at a time. One solution at a time. I can't explain my AA experience any better than that.

BLAST FROM THE PAST



This small. craftsman house, tucked away on a quiet street in Akron, Ohio, was life-long the home of Dr. Bob Smith and his wife. Anne Ripley Smith. Built in 1915, the house was where Smith Dr brought his bride in 1916 and where they lived

for the next 34 years until their deaths: Anne in 1949 and Dr. Bob in 1950.

It was here, in this humble home, that Dr. Smith was to take his incredible journey through the twelve steps and into history as the Founder of Alcoholics Anonymous. It was in this house and surrounding neighborhood where the miracle of recovery began for many hundreds of men and women; individuals who went on to spread this welcome message of recovery around the world.

Many visitors have spoken of a feeling of oneness with the spirit of AA as soon as they climbed the front steps and crossed the threshold. It is our hope and belief that you will too. Many once- hopeless alcoholics, Dr. Bob among them, made their first shaky steps toward recovery in this place.

Walking through these rooms, we may reflect on those days in the 1930s and 1940s when the Smiths and their visitors spoke of spiritual matters, and reflected in gratitude, on how dramatically their lives had changed because of them.

The Home was named a National Historic Landmark on Oct. 31, 1985, Dr. Bob's Home was named a State Historical Site by Governor Richard Celeste. On October 17, 2012, Dr. Bob's Home was named a National Historic Landmark. Dr. Bob's Home is one of only two National Historic Landmarks in Summit County and one of 73 in the state of Ohio.

Trustee at Large (District 2 liaison): Jeremy L.

District 2 has a couple new GSRS; still trying to fill 4 alternate DCM positions. Open Central Office positions have been announced. Please see District 2 newsletter.

Trustee at Large (District 10 liaison): Declan The District 10 meeting was held on February 3rd and well-attended with 21 GSRs and a total of 27 participants. The district made a generous contribution to Central Office for which we are very grateful. Time primarily given to GSRs for introduction to the newly-formed board and to bring questions to the floor. Next month, floor time will be given over to an area visitor who has been invited to make a presentation. The district's dispatch is attached. During last week's board meeting, I presented three motions aimed at enhancing transparency, financial management, and the effective fulfillment of our primary mission. The first motion focuses on identifying and addressing issues related to excess funds. The second motion proposes conducting a group inventory of Central Office. The third motion seeks to amend our bylaws to improve financial transparency. These motions will come up later in the meeting in new business. Declan listed the responsibilities of a Trustee and referred to the inverted pyramid. Brought up corporate poverty in Tradition 7 - Central Office has ceased making 7th tradition contributions to GSO. Alan said we would be talking about solutions at the March board meeting.

Trustee at Large (District 13 liaison): Julia M. District 13 is quite strong. They filled the critical treasurer position and one DCMC spot. They're still needing to fill two service positions. I was able to visit a couple new-to-me groups. Both are doing exceptionally well. I'd like to highlight the Thursday night, 8pm, Herriman High School meeting. It meets in the media center just inside and to the right of the main entrance. It has about 30 people consistently attending. They're well-bonded and talk steps and sponsorship. Check it out!

STEP 3 - MADE A DECISION

"Made a decision to turn our will and our lives over to the care of God as we understand Him." Practicing Step Three is like the opening of a door which to all appearances is still closed and locked. All we really need is a key and the decision to swing the door open.

There is only one key, and it is called willingness. Once unlocked by willingness, the door opens almost of itself, and looking through it, we shall see a pathway beside which is and inscription. It reads: "This is the way to faith that works."

In the first two steps we were engaged in reflection. We saw that we were powerless over alcohol, but we also perceived that faith of some kind, if only in AA itself, is possible to anyone. These conclusions did not require action: they required only acceptance.

Step three calls for affirmative action, for it is only by action that we can cut away the self-will which has always blocked the entry of God - or, if you like, a Higher Power - into our lives. Faith, to be sure, is necessary, but faith alone can avail nothing. We can have faith, yet keep God out of our lives. Therefore our problem now becomes just how and by what specific means shall we be able to let Him in? Step Three represents our first attempt to do this. In fact, the effectiveness of the whole AA program will rest upon how well and earnestly we have tried to come to "a decision to turn our will and our lives over to the care of God as we understood Him,"

In Heaven a recently deceased priest and a cab driver are shown their reward for their earthly endeavors. To the priest's disappointment he's given the keys to a small shed


